Apparently we are going to complete this agreement soon. Please make every effort to release the listings earliest possible. The timing is very critical at this point.

The future success of the book is largely dependent on effective circulation. I will make every effort to provide sufficient copies but I ask ASTCA to make every effort to provide effective distribution. Having the books available at the bill payment counter has not been an effective means of distribution. Advertisers are complaining about not having books 'everywhere'. Perhaps we can work together to insure good distribution to the business and government offices. I am willing to put a full-time person on that project for a couple of weeks.

I am sure 11k will be more than adequate if the books are managed properly. Our new relationship gives us the freedom to begin processing the 2012 book immediately when the 2011 book is distributed. If we keep the time span between books to 12 months, there will be plenty.

Also, the downloading and use of the digital edition of the book has become quite popular. My site, pagopago.com, where the digital book is available, has only that one item on it and the bandwidth used on that site is quite large. This indicates there must be many books being downloaded even now. ASTCA can put the book on their site too. This takes the pressure off the paper books.

So far so good. The residential listings are down to a few hundred that are missing village names or have subscriber name conflicts that need to be resolved. I've started work on filtering and cleaning up the business listings. 60% of them should be simple, 1-3 lines per location. 40% will likely have PBX systems, which will take some figuring out, but that isn't insurmountable.

The final format of the CSV for the listings is:
<lastname firstname initials, suffix>, <description 1>, <description 2>, <village name>

Description 1 = descriptions for the line such as "Director" or "Prayer Line"
Description 2 = facsimile machine

Any changes or if you want to merge the descriptions to a single field, let me know.

He is also telling John that "The final format of the CSV for the listings is.... This statement proves that JD has no idea what he is doing or that he considers CSV to be another term for Excel files. You see, CSV has no formatting: not even bold, tabs, columns, until the CSV file is loaded into Excel or some other program that provides the formatting.

Q: Did you read this email?

Just so everyone knows, I am 15% done with the Business White Page listings.

The Government Agency White Page listings are also grouped and filtered and I will be ready to hand those off to the operators on Monday for them to start calling government agencies to verify the #'s they want to list, and how they want them listed.

My best estimate for completion of the business and government listings is two and a half weeks with the help of the operators to do the last and final verifications via phone calls to customers.

I have already grouped and labeled Government vs. Commercial/Private #'s, Semi-Private entities (ASPA/ASTCA/ASCC), and have a sub-class of Commercial/Private for companies with a lot of lines and accounts, as well as a sub-class for organizations like the churches that have multiple locations. I'll be using any internal resources I can get my hands on, including the operators and communicators to do the verification calls and to send a fax to those customers. I estimate that the final 5-10% of listings that require direct contact to sort out their listings data will take up the bulk of the second week of April.

This is detailed and time consuming work that is constantly on-going. I will send out an email when I hit the 50% and 90% work completion milestones, which I estimate (for 50%) will around Wednesday or Thursday next week. The last 3 days of the 2.5 endgame period will be updating the Directory data with changes made by customers as recent as the last 8 weeks, or since the last directory data dump from our billing database.

We are including a Bill Message on the April 1 bill for customers to update their listings info by April 15.

I have already emailed the Rotary Club and Chamber of Commerce to inform them of the deadline.

I am waiting to see if I can get the contact info for the Lion's Club secretary and the Women's Professional Business group contact info to get a notice out to them about the deadline. While I've spoken with many of the members from each of the organizations, only a few of them have responded by sending me their info.

We are closing in and work is progressing. It goes without saying that I have other projects that are on-going as well at this time that are eating into my time. But this is the last update until I hit the 50% completion mark sometime middle of next week.

We need all of this data anyway to update our database once and for all. We will load all of the corrected information back into the iVue Directory database and I am planning some additional training for Customer Service staff on the issue of Directory Name/Info data integrity and quality. Next year we shouldn't have this problem.

Throughout the world, telephone directories are the source of vital and emergency information. We have done a pretty good job of providing that information for many years. But, the listings you are trying to give me do not meet minimum requirements. It is clear that ASTCA simply doesn't know who their customers are.

Your comments about formatting demonstrate your lack of ability and/or understanding of your objective. My thirteen-year-old daughter has it figured out just fine. So don't worry about those things that are so perplexing to you. Just give me the listings in a format similar to the previous 10 years' and we'll take it from there. But the listings must be COMPLETE AND ACCURATE!

Perhaps you should have Margaret handle this. She has been doing a much better job than you for many years.

Oh, and btw if you think I'm angry, you finally got it. You have cost me 10s if not 100s of thousands of dollars in lost revenues and unnecessary expenses.

Hi John,

I have put some updated exports into the drop box. There was an old filter parameter that excluded all Telecoms from the drafts due to all the lines used for testing or circuits (hence no BlueSky or ASTCA). I've removed the filter from the script. DOE has never responded to requests for their listing preferences for the schools, and both myself and ASG ITD attempted to get that information. The data for DOE, never having been verified was excluded until they respond to either my request for verification or ASG ITD's request.

LBJ has responded with their preferred listing since the last export and their listing now shows up in the exports. No other ASG agencies other than the ones that responded to ASG ITD have responded to queries and were excluded. As most ASG agencies are listed in the Brown Pages rather than the White Pages, offices identified as ASG are excluded by default from the white pages export.

The unlisted #'s were removed early on based on a list of people who had been current on their payments for that feature. I'll pull a new report on that feature as doubtless others have added their feature to their account.

As I stated before, after spending a lot of time working with export scripts the formatting you've requested is practically impossible to do as part of the database export. The problem is the insertion of empty rows and extra columns.
